Notes from the President

Once again, mother nature helped me with the content of this President's Letter. As I write this, Darnestown is recovering from a snow storm that left most of us without power for up to 4 days. I grew up in upstate NY where it was not unusual to have snow over the top of our vard light (5'). I don't remember ever losing power during a snow storm. What's the problem here? Pepco is the problem. The Public Service Commission (PSC) is the problem. Elected officials are the problem. Until our government representatives put pressure on the PSC to stick Pepco's hand in the socket, nothing will change. Ike Leggett has put together a task force to bring forth a list of demands and expectations for Pepco. Art Slesinger, our Utility Chairman, is serving voluntarily on this task force and for that, we thank him dearly. Governor O'Malley posted a letter on January 29, 2011 to Pepco's Chairman. An excerpt of this letter is as follows:

"It is with great frustration and enormous concern for the 26,000 Montgomery County residents that remain without power that I write, yet again, to express my anger that we seem to be back where we started. (Cont'd on page 3)

Why can't Pepco perform as its fellow utilities do? To date, BGE has restored service to 227,800 of the 233,500, or 98%, of its customers affected by the storm. Pepco still has 27,500 customers in Maryland without electricity, a restoration rate of a dismal 80%. I am also outraged that your customer communication remains unacceptable; the outage map posted to your website crashed yet again, leaving customers seeking information about their outage in the dark."

I know I sound like a broken record, but the squeaky wheel gets the grease, right? When we took Pepco's President around Darnestown back in November, there seemed to be agreement that more drastic cutting of trees and limbs was needed. When asked, there was no mention of any changes to infrastructure, aging equipment, better response time, etc. We understand that Pepco purchased property on the northwest corner of Rt.28 and Riffle Ford Road to potentially build a new substation. If built, it would seem that this would definitely help our situation. How long will that take? I keep informing Pepco that because many of us rely on wells for water, we lose that necessity as well. Water is needed to sustain life. Enough said. We are working very hard on this issue and hope that someone will eventually listen.

On a brighter note, mark your calendars for the DCA's Spring Social to be held at Smokey Glen Farm on April 28th. Do to the economy, the event is no longer free, but we hope the minimal charge per person will encourage you to attend. Look for the RSVP on page 18.

Seneca Forest Project

Why? Anyone who knows the woods around here has seen and understands the trouble our native forest is in. Practically every sapling of every native tree species is being eaten during their first or second year. Practically every spring wildflower and most other forest floor plants are also being extinguished. Several non-native invasive species are supplanting our native species in many areas. The deer don't seem to eat these foreign invasive plants. The DCA (consult past issues of the Acorn) has requested that we build 2 experimental exclosures in the Seneca State Park on our side of the creek with our own funds and maintain/monitor the fenced areas. The Department of Natural Resources and the Seneca State Park Management has given us permission to proceed with this project. Their specialists will advise us on removal of the non-native plants in and around our sites. Those involved are excited about this forest laboratory. Some have already attended a County program called Weed Warriors. This program trains volunteers to be permitted to remove/kill non-native species in the County parks. Our project committee should recommend that all volunteer monitors take this short free course.

The two exclosures are in a rough hexagon shape with each side about 100 feet. This computes to about 27,000 sq. ft. per site. An acre is 43,560 sq. ft. In early November a group of volunteers on several work days placed all of the necessary fence posts in the ground at our 2 sites in the Seneca Creek State Park. Those volunteers were James Wheeler, Scott Mostrom, Dave Bivans, Dan Dean, Pete Carstensen, Dick Jurgena, and Kevin Keegan. We rented an Auger for the 16 posts set in concrete. Twelve of these were corner posts with 2 brace posts for each corner. Between the corners are a

total of 21 heavy-duty posts and 60 10' angle posts. There will be two 4' wide gates for each exclosure that have been assembled. Carrying all of this stuff, including 22 bags of Sakrete, to the sites even utilizing wheel barrows for some of the materials was the least fun aspect.

The fencing materials were purchased from a Deerbusters outlet north of Frederick Delivery was free. The cost thus far has been \$3,800. At a town meeting last year, the DCA voted to allot an initial \$5,000 for the project. One of our interested members, Gary Kahn, donated \$500 toward the cost. The strongest plastic 8 foot fencing on the market (that we are aware of) plus supplemental necessities will also be purchased from Deerbusters at a cost of about \$3,300. We solicited a couple of commercial fence companies looking for a charitable price, and the over the phone "lowest possible cost" for both exclosures was \$12,000. These people, I'm confident, would have increased the price after seeing where they were to be installed.

Bruce Deppa has ordered some plastic boxes for informative brochures that will be located around the sites. We are hoping to install the fence in late March before the Spring growth begins. I have a list of volunteers for the work ahead. If you are interested in helping out, please do and let me know (301-330-0699).

News from the Upcounty Citizens Advisory Board

County Executive Calls for Ban On Roadside Solicitation Without A Permit

At many intersections throughout the County, individuals can be found selling goods, panhandling or soliciting for charity from the medians. We have all seen individuals who are soliciting drivers step off the median or adjacent sidewalk and into the road to collect money, putting themselves and motorists at risk. In early 2010 the County Executive convened a task force which reported in November that roadway solicitation is often hazardous to both panhandlers and motorists, and can potentially undermine the County's comprehensive efforts to promote pedestrian safety. The report noted that, while some panhandlers are homeless, appropriate services exist in the County to serve these individuals, and panhandling can often be counterproductive to addressing homelessness as well as addiction problems. As a result of this report Mr Leggett has requested that State legislators who served on the Task Force introduce a bill in the 2011 Session that would authorize the County to establish a permit system for roadside solicitation. Under the proposed bill, solicitation from a median strip or sidewalk adjacent to a roadway without a permit would be prohibited. The proposed permit system should not negatively impact organizations like the Volunteer Fire Departments in any way. This local permit system would augment current State law, which already prohibits solicitation in a roadway.

County Seeks Budget Ideas and Comments via New, Easy-to-Use Link on Homepage

A new link on the Montgomery County homepage makes it even easier for residents to provide comments and ideas on government restructuring, cost savings and other thoughts about closing the County's projected \$300 million budget gap for the coming fiscal year (FY). The idea for the link, which connects to a budget response form, came from Montgomery County Councilmember George Leventhal. Resident feedback will be used by Montgomery County Executive Isiah Leggett, as he prepares his recommended operating budget, which will be presented to the County Council on March 15, and the Montgomery County Council during its budget deliberations. County Executive Ike Leggett held five budget forums in January throughout the County and the County Council is holding a series of Town Hall meetings to hear directly from residents about their suggestions. The new web page will provide

the public with access to decision makers, and citizens may take advantage of it and share their suggestions with the County Council and the County Executive. The County Council approves the FY 2012 budget in May. The new fiscal year begins July 1. The budget form is available directly at www.montgomerycountymd.gov/budgetcomments.

The Upcounty Citizens Advisory Board represents more than 300,000 residents in the Upcounty area, north of Shady Grove Road and including the communities of Boyds, Clarksburg, Damascus, Darnestown, Derwood, Dickerson, Gaithersburg, Germantown, Laytonsville, Montgomery Village, North Potomac and Poolesville.

The 20-member Board advises the Director of the Upcounty Government Services Center, the County Executive, elected officials, and government staff. It provides input on which services and programs should be provided and how they will be delivered. The Board reviews and comments on the County's capital and operating budgets and master plans; assists with strategies to tailor services to regional needs; and conducts workshops and forums. Some members represent the Board on other ad hoc committees.

Members serve three-year terms without compensation, meeting certain Monday evenings of every month and occasionally on Saturdays. Members are expected to serve on at least one subcommittee, which meets approximately one evening every month on its own schedule. We work with a wide range of social, land use, infrastructure, and public safety issues. We are committed to rational development planning and protection of the Agricultural Reserve, this is particularly relevant to Darnestown, as our community is immediately adjacent to it and the rural village nature reflected in planning and zoning is directly inflluenced by the Agricultural Reserve. As a representative representing Darnestown, I am committed to communicating issues of importance to our community up to the County government, and carry news and information back to our community. Utility Reliability

This is being written as we are all holding our breath awaiting the ice storms of the first week in February. The snow storm of January 26th left many of us in the dark for 2 to 4 days and tried the patience of all Montgomery County residences. The disappointment, again, with Pepco has produced an outpouring of proposed rules and regulations to mandate performance or penalty rules. The Public Service Commission (PSC) has crafted a proposal that looks good but has very low performance goals and insufficient penalties at this point. The Feldman/Berliner proposed regulations would mandate that PSC impose penalties for poor performance. The Governor has also implied that he would propose his own regulations with the same intent. All of these efforts are in response to justified public discontent but premature from the perspective that the PSC has already started a formal proceeding against Pepco for their poor performance during the snow storms of 2010. That proceeding demanded that Pepco hire and pay for an independent technical power consultant to evaluate performance and practices at Pepco. That report is not due to be available until the spring, after the legislative session has ended. That report will be central to our identifying deficiencies in the Pepco organization.

I continue to work with the County Executive Work Group on Pepco. In April we will issue a report to the County Executive with suggested improvements in both Pepco and PSC. Since we are not experts in electrical distribution, we are hoping the inferences we find in performance data will be explained in the experts report and lead to better and more definitive suggestions. Note that the County is a party to the PSC action on Pepco performance and can file substantive comments on Pepco's response to the PSC. So after much examination, there is no guarantee of any improvement. Pepco has suggested, but not promised, to invest \$50 million a year over the next 5 years to improve the Montgomery County power infrastructure. Sometime during the last 8 years their investment in tree trimming dropped off and even the new efforts are barely equivalent to what was expended in 2003.

Lastly, I would suggest that everyone keep in mind your calls to Pepco during outages are the only way they have to see the entire picture. So call in when the lights go out, and call again if you think local progress has past you by. Additionally, you can file an online claim with Pepco [http://www.pepco.com/home/emergency/claim] if you believe your expenses are not excluded by their

rather expansive exclusionary policy. The DCA will be continuing to discuss alternative routes to pressuring Pepco for better service. To the greatest extent possible and with the help of the DCA board, I carry the message to the County and the state that Darnestown residents are inadequately served and we will not back down until service improves! We recognize that unreliable power is one of few negative blots on our otherwise wonderful community.

Village Committee

The Franklin Press

The owners of the Franklin Press, Art and Lucille DeGraba Brown, received final approval for a Compact Postal Unit from the Postal Service last November. The Ikea-like construction materials should be delivered in March and it is hoped that postal operations will commence by April 1st. This should make a trip to the Village even more convenient for people from the broader surrounding area.

Harris Teeter

The temporary sign in front of the HT announces the installation of a back-up generator to protect the frozen and perishable foods in the *unlikely* event of a power outage. This is scheduled to be started on February 21. The generator will be located in the rear of the building; and unfortunately will be louder than the normal electrical operation. Let's hope that the power loss instances will be few and brief.

During the 2010 February's snow related outages, the HT lost all of the frozen and perishable foods. The company does have insurance for such events after a deductible. During the wet snow power outage in late January, the HT rented a generator, but the ice cream and the deli soups and salad well section was lost.

Metropolitan Washington Orthodox Senior Housing (MWOSH)

There are two parcels 655 & 708 totaling approx. 8 undeveloped acres on Seneca Road behind the Shell station that are owned by MWOSH. While this group represents all of the Orthodox Churches in the Washington Metropolitan area, many on the board of MWOSH are members of St. George Church in Bethesda. MWOSH received approval of Special Exception (SE) #2648 in late 2005. The SE is for a 35

bedroom unit for senior housing. The attractive facility would include a kitchen and other common areas. The DCA has been very supportive of this endeavor; in part because of an agreement with the organization to make excess septic capacity available (min. of half an acre) for a septic easement for the potential Country Inn on the adjacent property next to the Shell station. The additional septic capacity is vital for any prospective restaurant, because it would allow for at least 100 seats for dining. Speculation for a name of the restaurant has been the Seneca Inn.

A Special Exception is good for 3 years. MWOSH applied and received 2 one-year extensions. They have put a great effort and significant funds into this project, and have received almost all necessary county approvals. They anticipated breaking ground by the end of 2010. However, they needed a loan. While they obtained preliminary approval for a HUD insured loan, the underwriting standards changed, and they are not able to get a loan for sufficient funds to proceed. Also, the county housing authority required that 6 units be Moderately Priced Development Units. MWOSH was also seeking support from the County. However, in the current economy, the County could not commit to be providing funds. Given these financial disappointments, MWOSH has suspended the project. They will take the next few months or more to reassess what to do next.

Parcel 641 -- The Country Inn

This 1.8 acre parcel is adjacent to the C-1 zoned gas station and the small parcel with the weathered asphalt. It is L shaped with frontage on 28 and Seneca Road. This property is owned by Ben Sarfarazi who purchased it in 2005. His dream (as was ours) was to consummate a restaurant, but he never had sufficient backers to He has recently listed the property for \$465,000. That is less than what he paid for it. Both this property and the MWOSH properties are zoned RE-2 or residential 2 acre. The 2002 Potomac Subregion Master Plan recommends on page 99 that "Apply the RE-2/Country Inn zone to the 11 (actually about 10) acres on the east side of Seneca Road including parcels 655, 708, and 641." This is the only spot in the Village where the "Seneca Inn" could be established. Many in Darnestown have desired a restaurant here in the Village for many years. If the design and type of restaurant was approved by the town, they would have DCA's strong support. Great location for something like Hunters, Normandy Farm, Bassetts and the Comus Inn. Whoever is willing to take this on would be a local hero in the opinion of many.

A Darnestown Timeline

A few years ago, I got a notion to jot down a list of significant dates and milestones in Darnestown's history during the past 100 years so we could publish a timeline. This would augment two timelines illustrating Darnestown's very early history that are used every year on *Darnestown History Day* at Darnestown Elementary School. The first of these, *Chronology of the Darnestown/Seneca Area*, was created by Mrs. Ann Jett as a hand-lettered text on sheets of large poster paper, and the second, a 16-foot illustrated timeline scroll, was created by Mrs. Sharon Scopin.

As I began typing my initial draft, it grew very quickly into a much longer list than I could have imagined. Thinking of milestones and events turned out to be easy. Filling in the actual dates has been much more difficult, and I need help!

Since the list already has more than 200 entries, we will publish it in parts, spread over several issues of *The Little Acorn*, and we're asking you to provide any dates that you can. If you know exact dates, that's great; if you only know years and/or months, that's great too. As you can see, there's a lot of blank space in the date columns. The list is in no particular order yet – that will happen after we have lots of dates filled in, when sequencing it by date will be meaningful.

Please contact me by e-mail or telephone, and help fill in the blanks. For reference, all I really need is the line number in the left-most column and your info about that event or milestone.

Darne Bloomers Garden Club

During the winter months maybe some of you looked at your landscape and decided that some changes are needed, or



you thought about just adding or replacing some plants that will enhance your yard and give it a new look for the up-coming spring and summer.

Have you considered planting more Maryland native plants and shrubs?

Native plants are plants found in your area before our early settlers came (when extensive land clearing began and exotic plants were first introduced). Hundreds, if not thousands, of plants fall into this category. Many native plants are beautiful, and are not used in our neighborhood landscape designs. Since native plants have been growing and evolving in an area for thousands of years and have adapted to the local soils and climate, they are more likely to thrive with minimal care than exotic plants. That can mean less need for water, fertilizer and pesticides. Native plants are less likely to create environmental concerns should they "escape" from your garden, unlike aggressive invasives.

By using a greater variety of species, you will have more varied seasonal interest (flowers, berries, leaf colors, etc.) and you will encourage a more balanced population of beneficial insects that will help keep the harmful ones in check. You'll also attract more birds and butterflies to your yard. Of course, not every native plant will thrive in every location. It's important to know your site conditions and the requirements of the native plants when making a selection.

You may find Maryland native plants in special marked sections at your local nurseries. If you don't see them, ask the manager for a list so you can purchase them. If you would like a bigger selection than they offer are the nursery, then check online for your native Maryland garden and landscape list. You may also want to select the plants and shrubs that deer don't like. Your nursery managers will have that information also, and so will your websites.

During our December Darne Bloomers Garden Club meeting our guest speaker, Sarah Salomon, presented her demonstration of holiday floral and techniques, including mailbox swags, and then she led our Handson workshop creating a pave-style centerpiece.

For the January meeting, the guest speaker was Alex Dencker, manager of the Behnke's Nursery in Potomac. His topic was "Gardening with Native Plants and Managing Invasive Species." He inspired many of us to take a serious look at more native Maryland plantings for our landscrape.

The February meeting speaker was Nick Weber of Heritage Rosarium with a lecture on "The Lure of Old Garden Roses." If you have a place in your garden where the deer don't roam, these wonderful flowers are a must in any yard. They add such beauty to any setting.



Vaulting on Horseback at Butler School



Butler School, a private Montessori school for children 3 years through 8th grade, is unique in the local area for blending equestrian sports into its school life. Vaulting on horseback, long an essential part of learning to ride in Europe, is growing in popularity in this country – and particularly at Butler School!

Four years ago, vaulting was offered to Butler students as one of their after school activities, and now is enjoyed in many different ways on the school's campus. The younger elementary students vault for six weeks as part of their P.E class. Students also enjoy this sport after school, either through the "Kaleidoscope" after school program or classes with Butler Barn. Several children now compete on a vaulting team, with hopes of qualifying one day for regional and national competitions.

This equestrian sport, which is sometimes referred to as "gymnastics on horseback", has captivated girls and boys who love horses and physical challenges. Movements are first practiced on a "vaulting barrel"



before the vaulter mounts the horse. The vaulter practices movements on the horse's back while it is walking or trotting in a circle on a lunge line controlled by the trainer. A harness with handles, along with a thick horse pad, enables even the youngest vaulters to feel confident as they learn a variety of "positions" on the horse.

For anyone who is interested in taking up this exciting equestrian sport, vaulting is offered to children (ages 7-14) outside the school community through Butler Equestrian's program and during the summer at Butler Camp. As our mission statement declares, Mary of Nazareth School prepares academic program rooted in the faith and teachings of the Roman Catholic Church, as professed in the Creed, celebrated in the sacraments, lived in Christian virtue and affirmed in prayer.

Although faith is the heart of Mary of Nazareth School, quality education is our primary focus. We believe that smaller work groups and more individualized time with students help to realize our mission.

The year, we are excited to add Mrs. Moira Seminara and Mrs. Anne Peterson as the two assistants for the second and third grades classes. Their job is to assist with reading and math lessons, breaking the students into smaller workgroups. This lowers our student ratio in both subjects and in turn, increases student understanding. The assistants also provide administrative and testing support within the classroom.

The Mary of Nazareth School Board of Directors is devoted to using resources to reduce the teacher to student ratios. Currently, reading instruction for Kindergarten through grade three is conducted in classes of twenty, creating a 1:10 teacher to student ratio. Mary of Nazareth School has also invested an additional reading instructor in grades four and five which has reduced reading class size to fifteen students per class. Additionally, three groups of math are taught simultaneously in grades four through eight reducing class size and therefore better meeting student needs.

The administration, faculty, and staff of Mary of Nazareth feel strongly that the success we can quantify in math and reading is closely linked to our efforts of lowering our student teacher ratio.

Indoor Track News and Notes

The Northwest Jaguars had a dominant performance December 23rd at the Montgomery Developmental Meet. With five new school records established, the Jaguars are setting themselves up for a successful winter season. Sheldon Trotman jumped 44'7" in the triple jump to establish a new school record by over a foot. Sheldon also had set a new school record in the long jump on December 4. Along with Sheldon, Chris Miller ran two new school records on Wednesday evening. In two very exciting 1600 and 3200 races, Chris raced step for step with the other top distance runners in the county. He ran 4:35 in the 1600 and 9:51 in the 3200. Britt Eckerstrom had a spectacular day as a mid-distance runner. Anchoring the 4 x 800, Britt ran with such ease that I had to re-check my splits four times to ensure that I was correct. Indeed, I was. Britt split a 2:14 on the anchor leg. After this, Britt ran the open 500 in 1:16.8 to break her old record from last year. She then went on to lead off the 4x 200 relay which dominated the field.

Not to be outdone by these new school records, there were many other fantastic performances:

- Olivia Ekpone dominated the 55 meter dash and 300 meter dash.
- Naomi Sheppard ran a 5:34 in the 1600 as a freshman
- Andrew Kyeremeh ran 1:09 in the open 500

• The girls 4 x 200 ran 1:44 with all the splits at 26.5 or faster

NWHS Indoor Track claims two best-in-country records so far this season.

Olivia Ekpone and Britt Eckerstrom re-established why they are two of the best runners in the country this past weekend. Olivia won the 55 meter dash in a fully automatic time of 6.96 which tied the meet record and is the US #1 time in that event as of this weekend. Britt was not to be outdone as she ran the 500 meter dash in 1:15.07 fully automatic time to set a new meet record and to establish her place as the US #1 time in that event. Both of these ladies joined forces on the 4 x 200 meter relay which also won on Saturday in a blazing time of 1:44.11. In a tough race, the girls' held their own in the 4x 200 with India Knight and Sheridan Allen running also on that relay. Olivia's day was not done; however, as she won her third event of the day – 400 meter dash in 56.69.

The rest of the team also competed well. The girl's 4 x 800 meter relay ran a great race to place 3rd overall. That team was comprised of Achankeng Acha-morfaw – who ran an aggressive first leg, Kaitlyn Gularson – a junior who is running track for the first time, Christine DiNardo – a senior who is coming off of an individual state medal in cross country, and Naomi Sheppard – freshman who ran a spectacular anchor leg to bring home the bronze for the Jaguars.

Naomi came back to run 5:32 in the 1600 in only her 4th race at that distance.

Indoor Track County Meet Results

Congratulations to the Northwest Girls' indoor track and field team for dominating the competition last night in the Montgomery county championships.

The girls' were dominate from start to finish by sweeping all three relays (as they did last year). The 4 x 800 meter relay was an exciting event as BCC went out strong with a tough lead off leg. Achankeng Achamorfaw stayed strong and handed off in a solid 2nd place to newcomer Kaitlyn Gularson. Kaitlyn ran strong and raced well to hold the 2nd place position. Kaitlyn handed off to freshman Naomi Sheppard who also raced well to give Britt Eckerstrom the baton 35 meters behind BCC's anchor leg – Alex Doll. (Backstory – Alex Doll won the state championship as 9thgrader in the indoor 1600 and Britt was 2nd that year. They are both national level soccer players who will play for powerhouses next fall: Alex at Stanford and Britt at Penn State. Their opening game as freshmen in college will be against

each other). When Britt got the baton - there was no question that she was going after the win. She went out in her first 400 in 62 seconds (!) and continued to press the race. She took the lead with 300 meters to go and never looked back anchoring the team to their second county title and in an impressive 2:12.6 split!!!!

The girls 4 x 200 meter relay was also dominant. Leading off was Hayley Henshaw and she handed off in 2nd place. Britt Eckerstrom took the baton and passed the leader with 50 meters to go to give Sheridan Allen space to open up and race the third leg. Sheridan handed off to Olivia with breathing room and the Jaguars came home with another victory.

Not to be outdone, the 4 x 400 meter relay team, decided they needed to win as well. Achankeng Acha-morfaw led off with Britt running 2nd leg. Freshmen Tiara Wellman ran a studly third leg to give Olivia Ekpone the baton and to win the relay.

The boys' 4 x 400 meter relay ran very well to place 4th overall out of the 2nd heat. Winning their heat was Andrew Kyeremeh, Barry Solomon, Cameron Brown, and Jacob Brennan.

The Darnestown Civic Association, Inc. is a nonprofit corporation originally formed in 1967, which represents the interests of Darnestown area residents in all matters pertaining to the welfare of Darnestown and its residents. The general purposes of the DCA are explained in its bylaws and Articles of Incorporation. Payment of annual dues (\$25 per individual or family) enables you to vote on issues during Town Meetings.

The membership year of the DCA is January 1 through December 31, and annual dues billing statements are mailed out at the end of December each year, although dues may be paid any time during a given year. Current officers of the DCA are listed on Page 2 of *The Little Acorn*.

Boundaries: Since Darnestown is not incorporated, it has no official boundaries. The activities and focus of the DCA include an area of some 12 square miles, centered approximately at the intersection of Maryland Routes 28 and 112 (Darnestown Road and Seneca Road). Maps are available at Town Meetings.

The Little Acorn newsletter is published quarterly, in March, June, September and December. Its name derives from its origin as a tiny newsletter in the Ancient Oak subdivision more than 20 years ago. Now it is mailed (3rd class) to every residential address that we have in our DCA data base. Volunteers, based on information from membership remittance form and our Welcome Committee, maintain this name and address file. The newsletter should arrive in your mailbox early in each of the above months. If you don't receive an issue, please contact the editor or any DCA officer. Publication of The Little Acorn is entirely a volunteer effort except for the printing and mailing.

Town Meetings are held quarterly by the DCA, usually on the 2nd or 3rd Thursday of March, June, September and December in the Fellowship Hall of the Darnestown Presbyterian Church at the intersection of Route 28 and Turkey Foot Road. Meetings are scheduled for 7:30 p.m., but are not called to order until 7:45 to allow some time for meeting neighbors, etc. Each issue of *The Little Acorn* features an announcement about the upcoming Town Meeting.



Annual Meeting and Election of DCA Officers coincide with the Town Meeting in June. Nominations are announced in June edition of *The Little Acorn* in advance of the Annual Meeting in accordance with the bylaws of the GDCA.


