Derecho

The Wikipedia definition of derecho "is a widespread, long-lived, straight-line windstorm that is associated with a fast-moving band of severe thunderstorms." Wind gusts of up to 200 mph have been reported in the most extreme cases. The June 29, 2012 derecho took out power to more than 3.7 million customers starting in the mid-west, across the central Appalachians, into the mid-Atlantic. It started as a small thunderstorm cell in central Iowa and by 3 pm had become a derecho when it reached Fort Wayne, IN. In the aftermath, Maryland suffered 900,000 customers without power. This has been called one of the most destructive and deadly fast-moving severe thunderstorm complexes in North American history.

Pepco's response was, as always, less than desirable. Some of my neighbors, here on Esworthy, lost power for 8 days in 100+ degree weather. There seemed to be no coordination between the county and Pepco to identify dangerous situations and what should be tackled first. Pepco

didn't start recruiting outside help until Monday, July 2^{nd} , 3 days after the storm. Tom Graham, President of Pepco, said in a press meeting, "Are people really that mad about losing power for that long?" What planet did he come from? The lack of empathy is the icing on the cake. Pepco wants a rate increase? They lost profits during the storm and will be reimbursed. Read Art Slesinger's article in this *Little Acorn* to learn more. I am simply too angry to keep writing about this topic.

Utility Reliability

After the utility debacle of June 29th, PEPCO is once again under a great deal of scrutiny for the quality of its service. While the County government gets aggravated, the reality is the Public Service Commission (PSC) holds all the cards.

Since the 8 day outage, the PSC has rejected a majority of the PEPCO rate increase request. That process started in December of 2011 and was finally resolved in July of 2012. In the PSC announcement, they rejected more than half of the PEPCO justification. PEPCO rationale was not supported by increases in reliability. Costs associated with defending itself during the 2011 investigation case initiated by the PSC in 2010 (following extended outages caused by snow and summer storms) were not allowed. PSC started a new action, case 9298, which is examining the July 2012 outages. Hopefully, Darnestown citizens made their disappointment clear during the August 7th public hearing. The DCA filed its response in writing before the formal PSC hearing on 9/14 in Baltimore.

Once again the PEPCO customers are angry that our system seems fragile and PEPCO takes several days to get the imported power restoration crews up and running. Keep in mind that the PSC does not and cannot run the utility on a daily basis or focus on one area or feeder. By the middle of August, after this update was written, all the power companies will have filed their storm reports that detail how much damage was done and how they went about restoring power.

Intuitively, PEPCO always seems slower and less organized. The flow of information to the impacted community was slow and of little value. All too often restoration times were global system estimates and not feeder specific. If you phoned in, you may

or may not have gotten a knowledgeable, live person. Others reported having trouble getting a response for an immediate crisis of a live line on a public highway. Certainly, the Esworthy residents have the most to complain about as they were nearly the very last area restored. It is unclear why that was case, but in reality, someone is last. PEPCO continues to spend significant sums of our money upgrading the system and removing vegetation. At some point the \$900 million, five year improvement program will be completed and PEPCO will petition the PSC for a rate adjustment to cover their costs.

Septic Tanks and Zoning

Annapolis recently passed a change in the water pollution statute to require that new or upgrade septic tanks include Best Available Treatment (See COMAR 26.04.02) (BAT). Maryland Department of the Environment is in the process of changing the regulations. The genesis goes back to a Federal EPA Watershed Improvement Plan for the Chesapeake Bay that required all sources of pollution be better controlled. Annapolis figured this was a great back door to zoning changes that will limit growth to areas where there are municipal sewage treatment plants and make development in areas without sewers more expensive.

The bottom line is, if you have a septic tank and it fails or you have a major improvement to your property that uses a septic system, the County government can demand that your revised septic BAT adds between \$8000 and tank use BAT. \$13,000 to the cost of the tank. It also requires annual maintenance by a certified service person. The sorry side of this is that BAT will address less than 5% of the human waste component going to the Bay and the cost per pound removed is extravagant. One could argue that it would seem a holistic approach would be more economical than spending large sums of money to chase down very small sources of pollution.

Two Hundred Year Old Treasure in Darnestown!

Many of you may have heard the story of a family home that provided accommodation to Abraham Lincoln. Not only is that true, but our further investigation revealed the impressive history of **Montanverde**, the residence of Major George Peter.

Major Peter (1779 – 1861) was the last military officer commissioned by George Washington. During the War of 1812, he commanded a battalion in which Francis Scott Key was a private. His Georgetown Artillery was one of the few militia units to fight heroically at the Battle of Bladensburg in August 1814. Returning to civilian life, Major Peter was the first Democrat elected to the U.S. Congress from the Sixth Congressional District, which included Montgomery County, serving from 1815-19. A member of the Maryland House of Delegates from 1819-27, he then returned for a final term in Congress.

While an impressive house in Georgetown was Peter's official residence, Montanverde was constructed (1809-1812) as a family summer retreat. In 1827, Major Peter and his third wife, Ann Plater, moved permanently to Seneca and continued their social and political obligations at their country home. In 1848, a barbecue for 600 guests was held on the lawn to support the political campaign of presidential hopeful Zachary Taylor. It is in this context that the young congressman from Illinois, Abe Lincoln, was invited and stayed over night in the west wing, now referred to as the 'Lincoln Bedroom.'

Major Peter passed away in 1861 and Montanverde stayed in the Peter family for more than a century. Since 1916, it has been owned by two generations of the Harman family, who used it as a summer home and later rented out the houses and barns. An outstanding example of early 19th century farmhouse design, Montanverde retains much of its original architectural character and materials. It is listed in the National Register of Historic Places as a featured property in the Seneca Historic District. It is also designated on the Montgomery County Master Plan for Historic Preservation.

Regrettably, in September 2011 the main house and tenant cottage were condemned for occupancy by Montgomery County, and both lie vacant and in a vulnerable state. The Harman family subsequently placed the house and adjoining land (two parcels) up for sale.

Residents of Darnestown have a unique opportunity to protect this local legacy. A group of concerned citizens – including neighbors, preservationists, members of the Peter family, and other interested parties have organized to rescue Montanverde. While efforts to secure the property are in progress, our main concern is to stabilize the house, which will require a major outlay of funds. The longer term goal is to find a responsible private or public owner who will respect, restore, and maintain the property for now and future generations.

DCA Bids Adieu to Kathy & Steve By Bruce Deppa

Long-time Darnestown residents Steve and Kathy Ellis recently sold their home on Ancient Oak Drive and retired to their beach house in Ocean Pines, Maryland. This news prompted me to reflect on the critical roles that Steve has played during the



transformation of Darnestown from rolling pastures to suburban residential neighborhoods.

Kathy and Steve moved to Darnestown in 1984, and Steve very quickly became active in the Greater Darnestown Civic Association. In fact, Steve was one of the three Darnestown residents who created and recorded the association's re-write of its Articles of Incorporation in 1984. (The others were Marsha Crowley and Gerry Foley; this followed their discovery that the original Articles had been allowed to expire.) Steve held various positions on the association's Executive Board for more than 25 years, including terms as Vice-president and President. He focused especially on Montgomery County's updating of its Master Plan for the Potomac Subregion, related to controlling development in the Darnestown/Potomac area. His diligence and his encyclopedic knowledge of the county's development review process were key to achieving the association's goals during the master plan revision process.

On a lighter note, Steve established the Darnestown Civic Association's softball league in 1989 and served as the Softball Commissioner for 20 years. For years Steve, along with Bob Cangelosi, managed the decoration and lighting of the community Christmas Tree at the intersection of Darnestown Road and Ancient Oak Drive. Also, for many years, Kathy and Steve were instrumental in planning the Darnestown Hoedown held annually at Smokey Glen Farm.

One of Steve's favorite projects was the Maryland Scenic Byways Program. Steve worked with Maryland Delegate Judith Toth and with Governor William Donald Schaefer to designate portions of Darnestown Road and Seneca Road as Maryland Scenic Byways. More recently. Steve masterminded the establishment of two deer "exclosure" plots in Seneca Creek State Park. He worked with the Maryland Department of Natural Resources and with Darnestown volunteers to construct these fenced plots which are now being monitored to assess the severity of damage caused by grazing deer, and to determine how many "deerless" years it might take for natural recovery of the flora in such protected forest plots.

Over the years, Steve has been a tireless advocate for the Civic Association and for the residents of Darnestown. He constantly testified for the GDCA at public hearings before such Montgomery County governmental bodies as the County Council, the County Planning Board, the County Board of Appeals, the County Board of Education, the County Hearing Examiner, the County Department of Transportation, as well as the Maryland State Highway Administration, the Maryland Department of Transportation, and the Maryland State Department of Education.

JUST DARNESTOWN

A little local history from the Acorn Archives June 1999

Historically, Darnestown was considered to be the area roughly within a half-mile radius from the intersection of Darnestown and Seneca Roads. For this reason the residents in the newer developments of Ancient Oak, Mountain View, Ridgefield, and other areas outside of the traditional Darnestown

Boundaries called their new association, 'The Greater Darnestown Civic Association. "Carter Hubbel, Maurice Landers, and Mary Anderson signed incorporation documents officially creating 'The Greater Darnestown Civic Association' in October 1969. The title GDCA has served us well. It has true sentimental value and it's easy to say. But is it accurate and useful any more? As the years and issues have occurred, the greater Darnestown area has simply become Darnestown. County and State officials refer to us as Darnestown. Several years ago at the persuasion of John Kos and Bruce Deppa, the State Highway Administration put up new Darnestown signs at some of our actual boundaries.

The **Darnestown Planning Area** includes all of the area east of Jones Lane and south of Route 28 to the Muddy Branch Creek. Some, including myself, consider the Fox Hills area, Willow Ridge, the Quince Orchard High School and Shopping Center as part of the general Darnestown area though not within our civic association boundary. There may have been an unintended consequence of the term Greater. While having legitimate inclusionary meaning, it also connotes exclusion. For example, people moving into the newer developments in the late 70's and 80's east of Jones Lane found themselves outside of "Greater" Darnestown. This may not have mattered to some, but it must have been important to others. The Pulte developers had told the new residents that their young children would be going to Darnestown Elementary School. The school was small and on a septic system and would become quickly overcrowded. The suggestion was made that to alleviate overcrowding at Darnestown, some neighborhoods north of Rt. 28 could be sent to Diamond Farms Elementary. This created a very disruptive boundary dispute (not helped by our friends at the county public school system). However, all areas did attend Darnestown under crowded but mostly congenial circumstances until Jones Lane elementary school was opened in 1987. I believe that a lasting resentment by some in the Jones Lane area prevented a united front with Darnestown in the recent high school debacle.

The primary reason for this article is to suggest that we change our name to the Darnestown Civic Association. By doing so, the notion of a broader,

larger more inclusive greater Darnestown area *could* emerge in the future. This is not to suggest in any way that our current civic association boundaries be altered beyond what makes sense. One of our primary objectives has been to keep the sewer out of the area. This maintains the large lot, semi-rural area that has attracted us. Our citizens past and present have demonstrated the willingness in time, work, and in significant financial campaigns to help protect this place. We really cannot expand our civic association boundaries to the east. Would people living in more densely populated areas served by WSSC be willing to spend tens of thousands of dollars to prevent unwanted intrusions (e.g. sewer or larger than desired shopping centers) into our part of Darnestown? I think not. Could their sheer number of votes outside our traditional boundaries defeat motions to exercise some of our most basic goals? Yes. These are true reasons why we cannot expand our civic association boundaries, not some artificial or perceived differences.

To acknowledge the fact that we are "Darnestown" and to open the general area to the possibility of a broader Darnestown coalition or alliance in the future that can unite us all, we need to officially change our name to the Darnestown Civic Association. This would require a change in the by-laws and our Incorporation documents - all subject to votes by the membership. This change should be completed soon so that any reference to our association in the year 2000 Potomac Sub-Region Master Plan would be the Darnestown Civic Association.

This change was ratified and we are now the DCA (Darnestown Civic Association) as a result.

Darne Bloomers Garden Club

Many of us in Darnestown have relatively large areas of lawn. We have the opportunity to create a more environmentally-friendly landscape bv replacing at least some of that lawn with native trees, shrubs and perennials. Fall is a great time to plant-particularly trees and shrubs. A remarkable abundance of life is supported by a relatively small investment in native landscaping. More home owners are choosing to reduce their lawn areas (reducing mowing pollution and lawn-care chemicals), creating life-sustaining landscapes instead. This reduces stormwater runoff, directly improving local streams and rivers. You may have noticed that much of the undergrowth in our woods is now alien invasive species. When we plant (and protect from the deer) native trees, shrubs and perennials in our yards, we can collectively make a significant difference in habitat availability, as well as improve water and air quality. Montgomery County has a RainScapes program--a funding and

information resource if you want to create a rain garden or convert a lawn area to conservation landscaping. For more information contact www.montgomerycountymd.gov/rainscapes.

I recently applied for a RainScapes grant to do conservation landscaping to replace part of our front lawn. I was curious about the process and wanted to be able to report from experience on this program (I'll provide more details next spring, once the project is completed). I have been awarded the grant and will be installing the landscaping this fall. If you are interested in talking with a local gardener about this program, please contact me at merikays@verizon.net.

Our September meeting of Darne Bloomers will be on "Growing and Cooking with Herbs" with Jeff Eng, Executive Chef at Clyde's Tower Oaks Lodge, as our guest speaker. Chef Eng completed his culinary degree from L'Academie de Cuisine in Bethesda and has served as the Executive Chef to Clyde's of Georgetown prior to Clyde's Tower Oaks.

The Darne Bloomers meet at the Darnestown Presbyterian Church on the second Thursday of each month. Information for Newcomers

If you are a new resident of Darnestown, welcome to our neighborhood! The information in this section should be helpful and will introduce you to some things that give Darnestown a sense of community.

The Darnestown Civic Association, Inc. is a nonprofit corporation originally formed in 1967, which represents the interests of Darnestown area residents in all matters pertaining to the welfare of Darnestown and its residents. The general purposes of the DCA are explained in its bylaws and Articles of Incorporation. Payment of annual dues (\$25 per individual or family) enables you to vote on issues during Town Meetings.

The membership year of the DCA is January 1 through December 31, and annual dues billing statements are mailed out at the end of December each year, although dues may be paid any time during a given year. Current officers of the DCA are listed on Page 2 of *The Little Acorn*.

Boundaries: Since Darnestown is not incorporated, it has no official boundaries. The activities and focus of the DCA include an area of some 12 square miles, centered approximately at the intersection of Maryland Routes 28 and 112 (Darnestown Road and Seneca Road). Maps are available at Town Meetings.

The Little Acorn newsletter is published quarterly, in March, June, September and December. Its name derives from its origin as a tiny newsletter in the Ancient Oak subdivision more than 20 years ago. Now it is mailed (3rd class) to every residential address that we have in our DCA data base. Volunteers, based on information from membership remittance form and our Welcome Committee, maintain this name and address file. The newsletter should arrive in your mailbox early in each of the above months. If you don't receive an issue, please contact the editor or any DCA officer. Publication of *The Little Acorn* is entirely a volunteer effort except for the printing and mailing.



Town Meetings are held quarterly by the DCA, usually on the 2nd or 3rd Thursday of March, June, September and December in the Fellowship Hall of the Darnestown Presbyterian Church at the intersection of Route 28 and Turkey Foot Road. Meetings are scheduled for 7:30 p.m., but are not called to order until 7:45 to allow some time for meeting neighbors, etc. Each issue of *The Little Acorn* features an announcement about the upcoming Town Meeting.

Annual Meeting and Election of DCA Officers coincide with the Town Meeting in June. Nominations are announced in June edition of *The Little Acorn* in advance of the Annual Meeting in accordance with the bylaws of the GDCA.

Telephone Directory: Every two years, the DCA publishes a directory of residents' names, addresses and phone numbers and mails it to every residential address in our database.
